Report on the Audit of the Financial Statements

Qualified Opinion

We have audited the financial statements of Gateway Office Parks Private Limited (the "Company") which comprise the balance sheet as at 31 March 2024, and the statement of profit and loss (including other comprehensive income), statement of changes in equity and statement of cash flows for the year then ended, and notes to the financial statements, including material accounting policies and other explanatory information.

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid financial statements give the information required by the Companies Act, 2013 ("Act") in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India, of the state of affairs of the Company as at 31 March 2024, and its loss and other comprehensive loss, changes in equity and its cash flows for the year ended on that date.

Basis for Qualified Opinion

As mentioned in Note 36(i), the statutory auditors of earlier years have notified vide letter dated December 17, 2020, that they withdraw their audit reports on the financial statements as of and for the financial years ended March 31, 2018 and 2019 as they do not continue to remain valid and informed the Company that auditor's report on the financial statements referred above must no longer be associated with the said financial statements. The Company, based on advice received from its external legal counsel, has replied that it rejects the above letter in its entirety. The Company believes that in accordance with the Companies Act, the financial statements for the years ended March 31, 2018 and 2019 remain audited, and the erstwhile auditors motion to withdraw the audit reports is not legally acceptable.

Given the dispute between the Company and the predecessor auditor with respect to the previously issued audit reports of the Company by the predecessor auditor, while we have audited adjustments made to the previously issued financial statements, we are unable to obtain sufficient appropriate audit evidence as to how this dispute would be finally concluded upon and therefore any impact on the previously audited financial statements of the Company for the year ended March 31, 2019 or prior periods is currently not determinable.

We conducted our audit in accordance with the Standards on Auditing (SAs) specified under Section 143(10) of the Act. Our responsibilities under those SAs are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are independent of the Company in accordance with the Code of Ethics issued by the Institute of Chartered Accountants of India together with the ethical requirements that are relevant to our audit of the financial statements under the provisions of the Act and the Rules thereunder, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the Code of Ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion on the financial statements.

Management's and Board of Directors Responsibilities for the Financial Statements

The Company's Management and Board of Directors are responsible for the matters stated in Section 134(5) of the Act with respect to the preparation of these financial statements that give a true and fair view of the state of affairs, profit/ loss and other comprehensive income, changes in equity and cash flows of the Company in accordance with the accounting principles generally accepted in India, including the Indian Accounting Standards (Ind AS) specified under Section 133 of the Act. This responsibility also includes maintenance of adequate accounting records in accordance with the provisions of the Act for

safeguarding of the assets of the Company and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, the Management and Board of Directors are responsible for assessing the Company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the Board of Directors either intends to liquidate the Company or to cease operations, or has no realistic alternative but to do so.

The Board of Directors is also responsible for overseeing the Company's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with SAs will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with SAs, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances. Under Section 143(3)(i) of the Act, we are also responsible for expressing our opinion on whether the company has adequate internal financial controls with reference to financial statements in place and the operating effectiveness of such controls.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by the Management and Board of Directors.
- Conclude on the appropriateness of the Management and Board of Directors use of the going concern basis of accounting in preparation of financial statements and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Company's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Company to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

We also provide those charged with governance with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related

safeguards.

Other Matter

- a. The financial statements of the Company for the years ended March 31, 2019, and March 31, 2018, were audited by another auditor. However, as stated in Basis of Qualified Opinion section of our report, the said auditor has sent a letter to the Company dated December 17, 2020 stating that they withdraw their audit reports on the financial statements as of and for the financial years ended March 31, 2018 and 2019.

Our opinion is not modified in respect of this matter.

Report on Other Legal and Regulatory Requirements

1. As required by the Companies (Auditor's Report) Order, 2020 ("the Order") issued by the Central Government of India in terms of Section 143(11) of the Act, we give in the "Annexure A" a statement on the matters specified in paragraphs 3 and 4 of the Order, to the extent applicable.

 - a. We have sought and, except for the matters described in the Basis for Qualified Opinion paragraph, obtained all the information and explanations which to the best of our knowledge and belief were necessary for the purposes of our audit.

 - c. The balance sheet, the statement of profit and loss (including other comprehensive income), the statement of changes in equity and the statement of cash flows dealt with by this Report are in agreement with the books of account.
 - d. In our opinion, the aforesaid financial statements comply with the Ind AS specified under Section 133 of the Act.
 - e. The matter described in the Basis for Qualified Opinion paragraph above, and "Disclaimer of opinion" paragraph in "Annexure B" with respect to adequacy of the internal financial controls with reference to financial statements of the company may have an adverse effect on the functioning of the Company.
 - f. On the basis of the written representations received from the directors as on 04 April 2024 taken on record by the Board of Directors, none of the directors is disqualified as on 31 March 2024 from being appointed as a director in terms of Section 164(2) of the Act.
 - g. The qualification relating to the maintenance of accounts and other matters connected therewith are as stated in the Basis for Qualified Opinion paragraph above and the qualification relating to the maintenance of books of accounts as stated in the paragraph 2(A)(b) above on reporting under Section 143(3)(b) and paragraph 2B(f) below on reporting under Rule 11(g) of the Companies (Audit and Auditors) Rules, 2014.
 - h. With respect to the adequacy of the internal financial controls with reference to financial statements of the Company and the operating effectiveness of such controls, refer to our separate Report in "Annexure B".
- B. With respect to the other matters to be included in the Auditor's Report in accordance with Rule 11 of the Companies (Audit and Auditors) Rules, 2014, in our opinion and to the best of our information and

In the absence of reporting on compliance with the audit trail requirements in the independent auditor's report in relation to controls at service organisation for such accounting software, we are unable to comment whether audit trail feature of the said software was enabled and operated throughout the year for all relevant transactions recorded in the software or whether there were any instances of the audit trail feature being tampered with.

1 Background of the Company

Gateway Office Parks Private Limited ("the Company") is primarily engaged in providing infrastructure services, which includes developing Special Economic Zone ('SEZ') and leasing out space to companies in the information technology sector. The Company was a 50:50 joint venture between Shriram Properties Private Limited ('SPL') and Sun Apollo Investment Holding LLC (Later renamed as Gateway Office Parks Holdings Limited). In the year 2017-18, Horus Holding Pte Ltd. acquired the shares of the Company held by SPL. vide share purchase agreement dated April 22, 2017. The Company changed its name from Shriram Properties & Infrastructure Private Limited to Gateway Office Parks Private Limited. The registered office of the Company is located at Block A-6, Ground Floor, No.16, GST Road, Perungalathur, Chennai - 600063.

2 Basis of preparation

(a) Statement of compliance

These financial statements have been prepared in accordance with Indian Accounting Standards (Ind AS) as per the Companies (Indian Accounting Standards) Rules, 2015 notified under Section 133 of Companies Act, 2013, (the 'Act') and other relevant provisions of the Act.

These financial statements were authorized for issue by the Company's Board of Directors on September 25, 2024.

Details of the Company's accounting policies are included in Note 3.

(b) Functional and presentation currency

These financial statements are presented in Indian Rupees (INR), which is the Company's functional currency. All the financial information have been presented in lakhs of Indian Rupees (INR) except for share data and as otherwise stated.

(c) Basis of measurement

These financial statements have been prepared on the historical cost basis except in case of certain financial assets and financial liabilities that have been measured at its fair values.

(d) Use of estimates and judgements

The preparation of these financial statements in conformity with the recognition and measurement principles of Ind AS requires management to make judgements, estimates and assumptions, that affect the application of accounting policies and the reported amounts of assets, liabilities, income, expenses and disclosure of contingent assets and liabilities at the date of these financial statements and the reported amounts of revenue and expenses for the years presented. Actual results may differ from these estimates.

Estimates and underlying assumptions are reviewed at each balance sheet date. Revisions to accounting estimates are recognized in the period in which the estimates are revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Key sources of estimation of uncertainty at the date of the financial statements, which may cause a material adjustment to the carrying amounts of assets and liabilities within the next financial year, is in respect of useful life of property, plant and equipment, investment property, income taxes and contingencies and commitments.

Note 3(c) and 3(d)- measurement of useful life and residual values of property, plant and equipment and investment property

Note 3(i)- Management judgement is required for estimating the possible outflow of resources, if any, in respect of contingencies/claim/litigations against the Company as it is not possible to predict the outcome of pending matters with accuracy

Note 3(l)- judgement required to determine probability of recognition of current tax and deferred tax assets

Note 2(e)- fair value measurement of financial instruments

(e) Measurement of fair values

A number of the Company's accounting policies and disclosures require the measurement of fair values, for both financial and non financial assets and liabilities.

The Company has an established control framework with respect to the measurement of fair values whereby the valuation is obtained from an external independent valuer, wherever necessary, which is then reviewed by the management for the underlying assumptions used in the valuation.

The management regularly reviews significant unobservable inputs and valuation adjustments. If third party information, such as broker quotes or pricing services, is used by the valuer to measure fair values, then the management assesses the evidence obtained from the third parties to support the conclusion that these valuations meet the requirements of Ind AS, including the level in the fair value hierarchy in which the valuations should be classified.

Fair values are categorized into different levels in a fair value hierarchy based on the inputs used in the valuation techniques as follows.

- Level 1: quoted prices (unadjusted) in active markets for identical assets or liabilities.

- Level 2: inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly (i.e. as prices) or indirectly (i.e. derived from prices).

- Level 3: inputs for the asset or liability that are not based on observable market data (unobservable inputs)

When measuring the fair value of an asset or a liability, the Company uses observable market data as far as possible. If the inputs used to measure the fair value of an asset or a liability fall into different levels of the fair value hierarchy, then the fair value measurement is categorized in its entirety in the same level of the fair value hierarchy as the lowest level input that is significant to the entire measurement.

The Company recognizes transfers between levels of the fair value hierarchy at the end of the reporting period during which the change has occurred.

Further information about the assumptions made in measuring fair values is included in the following note:

- Note 6 – investment property.

(f) Going concern

The Company has incurred losses during the year amounting to INR 12,354.11 Lakhs, which along with the existing accumulated losses has resulted in erosion of net worth. The Company has also incurred operating cash loss during the year. This necessitates the evaluation of the Company's ability to continue as a Going concern and meeting its obligations to the stakeholders, creditors, employees and lenders. Management has carried out an assessment of the appropriateness of going-concern, impairment of assets and other related aspects as on the date of approval of these financial results. Basis the business plan of the Company they intend to continuously focus on leasing the available office spaces to improve profitability. The Management is also in advanced discussions with a potential buyer for selling a part of the land where no construction has been proposed, accordingly the Company has reached out to the Lenders to obtain an No Object Certificate for selling such land. Based on the business plan, the Company expects to lease the remaining available space and continue to earn operating cash profits and expected to monetize the freehold land to strengthen its financial condition. Accordingly, the going concern assumption is appropriate.

3 Material accounting policies

(a) Foreign currency transactions

Transactions in foreign currencies are translated to the respective functional currency of the Company at exchange rates at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies at the reporting date are translated to the functional currency at the exchange rate at the reporting date.

(b) Financial instruments

(i) Recognition and initial measurement

Trade receivables are initially recognized when they are originated. All other financial assets and financial liabilities are initially recognized when the Company becomes a party to the contractual provisions of the instrument.

A financial asset or financial liability is initially measured at fair value plus, for an item not at fair value through profit and loss (FVTPL), transaction costs that are directly attributable to its acquisition or issue.

(ii) Classification and subsequent measurement

Financial assets

On initial recognition, a financial asset is classified as measured at

- amortized cost;
- Fair value through other comprehensive income (FVOCI); or
- Fair value through profit and loss (FVTPL)

Financial assets are not reclassified subsequent to their initial recognition, except if and in the period the Company changes its business model for managing financial assets.

A financial asset is measured at amortized cost if it meets both of the following conditions and is not designated as at FVTPL:

- the asset is held within a business model whose objective is to hold assets to collect contractual cash flows; and
- the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount

A financial asset is measured at FVOCI if it meets both of the following conditions

and is not designated as at FVTPL:

- the asset is held within a business model whose objective is achieved by both collecting contractual cash flows and selling financial assets; and
- the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount

All financial assets not classified as measured at amortized cost or FVOCI as described above are measured at FVTPL. A financial liability is classified as at FVTPL if it is classified as held-for-trading, or it is a derivative or it is designated as such on initial recognition. Financial liabilities at FVTPL are measured at fair value and net gains and losses, including any interest expense, are recognized in statement of profit and loss. Other financial liabilities are subsequently measured at amortized cost using the effective interest method. Interest expense and foreign exchange gains and losses are recognized in statement of profit and loss. Any gain or loss on derecognition is also recognized in statement of profit and loss.

The Company derecognizes a financial asset when the contractual rights to the cash flows from the financial asset expire, or it transfers the rights to receive the contractual cash flows in a transaction in which substantially all of the risks and rewards of ownership of the financial asset are transferred or in which the Company neither transfers nor retains substantially all of the risks and rewards of ownership and does not retain control of the financial asset.

If the Company enters into transactions whereby it transfers assets recognized on its balance sheet, but retains either all or substantially all of the risks and rewards of the transferred assets, the transferred assets are not derecognized.

Financial liabilities

The Company derecognizes a financial liability when its contractual obligations are discharged or cancelled, or expire.

The Company also derecognizes a financial liability when its terms are modified and the cash flows under the modified terms are substantially different. In this case, a new financial liability based on the modified terms is recognized at fair value. The difference between the carrying amount of the financial liability extinguished and the new financial liability with modified terms is recognized in statement of profit and loss.

(iv) Offsetting

Financial assets and financial liabilities are offset and the net amount presented in the balance sheet when, and only when, the Company currently has a legally enforceable right to set off the amounts and it intends either to settle them on a net basis or to realise the asset and settle the liability simultaneously.

(c) Property, plant and equipment**(i) Recognition and Initial measurement**

Items of property, plant and equipment are measured at cost, and includes capitalized borrowing costs, less accumulated depreciation and impairment losses, if any.

Cost of an item of property, plant and equipment comprise of its purchase price, including import duties and non-refundable purchase taxes, after deducting trade discounts and rebates, directly attributable cost of bringing the item to its working condition for its intended use and estimated costs of dismantling and removing the item and restoring the site on which it is located, if any.

If significant parts of an item of property, plant and equipment have different useful lives, then they are accounted for as separate items (major components) of property, plant and equipment.

Any gain or loss on disposal of an item of property, plant and equipment is recognized in statement of profit and loss.

(ii) Subsequent expenditure

Subsequent expenditure is capitalized only if it is probable that the future economic benefits associated with the expenditure will flow to the Company.

(iii) Depreciation

Depreciation is calculated on cost of items of property, plant and equipment less their estimated residual values over their estimated useful lives using the written down value method, and is generally recognized in the statement of profit and loss.

Depreciation on additions (disposals) is provided on a pro-rata basis i.e. from (up to) the date on which asset is ready for use (disposed of). Any gain or loss on disposal of property, plant and equipment is recognized in statement of profit and loss.

(d) Investment property**(i) Recognition and measurement**

Investment property is property held to earn rentals or for capital appreciation or for both rather than for use in the production or supply of goods or services or for administrative purposes or sale in the ordinary course of business. Upon initial recognition, an investment property is measured at cost. Subsequent to initial recognition, investment property is measured at cost less accumulated depreciation and accumulated impairment losses, if any.

(ii) Subsequent expenditure

Subsequent expenditure is capitalized only if it is probable that the future economic benefits associated with the expenditure will flow to the Company.

(iii) Depreciation

The estimated useful life of building for the current and comparative periods is 30 years

An item of investment property is derecognized upon disposal or when no future economic benefits are expected from its use. Profits and losses on disposals of items of investment property are determined by comparing the proceeds from their disposals with their respective carrying amounts, and are recognized in the statement of profit and loss.

The fair values of investment property is disclosed in note 6. Such fair values are determined after considering valuation by an independent valuer who holds a recognized and relevant professional qualification and experience in respect of the investment property being valued.

(e) Investment property under development

Property that is being constructed for future use as investment property is accounted for as investment property under development until construction or development is complete. Direct expenses like site labour cost, material used in project construction, project management consultancy, costs for moving the plant and machinery to the site and general expenses incurred specifically for the respective project like salary costs, insurance, design and technical assistance, borrowing costs and construction overheads are considered as the cost of the project.

Intangible assets under development

The Company expenses costs incurred during research phase to statement of profit or loss in the year in which they are incurred. Development phase expenses are initially recognized as intangible assets under development until the development phase is complete, upon which the amount is capitalized as intangible asset.

(f) Intangible assets

Intangible assets are stated at acquisition cost, net of accumulated amortization and accumulated impairment losses, if any. Intangible assets are amortized on a straight-line basis over their estimated useful lives. The amortization period and the amortization method are reviewed at the end of each financial year. If the expected useful life of the asset is significantly different from previous estimates, the amortization period is changed accordingly.

Computer software are amortized on a straight-line basis over a period of 10 years. Gains or losses arising from the retirement or disposal of an intangible asset are determined as the difference between the net proceeds from disposal and the carrying amount of the asset and recognized as income or expense in the Statement of Profit and Loss.

(g) Impairment

(i) Impairment of financial instruments

The Company recognizes loss allowances for expected credit losses on financial assets measured at amortized cost and FVOCI. At each reporting date, the Company assesses whether financial assets carried at amortized cost are credit - impaired. A financial asset is 'credit - impaired' when one or more events that have a detrimental impact on the estimated future cash flows of the financial asset have occurred.

Impairment loss is the difference between all contractual cash flows that are due to the Company in accordance with the contract and all the cash flows that the Company expects to receive (i.e. all cash shortfalls). The Company estimates cash flows by considering all contractual terms of the financial instrument through the expected life of that financial instrument.

The Company follows 'simplified approach' for recognition of impairment loss allowance on trade receivables which do not contain a significant financing component. The application of simplified approach does not require the Company to track changes in credit risk. Rather, it recognizes impairment loss allowance based on lifetime impairment pattern at each balance sheet date, right from its initial recognition.

Loss allowances for financial assets measured at amortized cost are deducted from the gross carrying amount of the assets. The gross carrying amount of a financial asset is written off (either partially or in full) to the extent that there is no realistic prospect of recovery. This is generally the case when the Company determines that the debtor does not have assets or sources of income that could generate sufficient cash flows to repay the amounts subject to the write-off. However, financial assets that are written off could still be subject to enforcement activities in order to comply with the Company's procedures for recovery of amounts due.

(ii) Impairment of non-financial assets

The Company's non-financial assets, other than inventories and deferred tax assets, are reviewed at each reporting date to determine whether there is any indication of impairment. If any such indication exists, then the asset's recoverable amount is estimated. For impairment testing, assets that do not generate independent cash inflows are grouped together into cash-generating units (CGUs). Each CGU represents the smallest group of assets that generates cash inflows that are largely independent of the cash inflows of other assets or CGUs. The recoverable amount of a CGU (or an individual asset) is the higher of its value in use and its fair value less costs to sell. Value in use is based on the estimated future cash flows, discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the CGU (or the asset).

The Company's corporate assets (e.g., central office building for providing support to various CGUs) do not generate independent cash inflows. To determine impairment of a corporate asset, recoverable amount is determined for the CGUs to which the corporate asset belongs. An impairment loss is recognized if the carrying amount of an asset or CGU exceeds its estimated recoverable amount. Impairment losses are recognized in the statement of profit and loss. In respect of assets for which impairment loss has been recognized in prior periods, the Company reviews at each reporting date whether there is any indication that the loss has decreased or no longer exists. An impairment loss is reversed if there has been a change in the estimates used to determine the recoverable amount. Such a reversal is made only to the extent that the asset's carrying amount does not exceed the carrying amount that would have been determined, net of depreciation or amortization, if no impairment loss had been recognized.

(h) Employee benefits

Short-term employee benefits

Short-term employee benefits are expensed as the related service is provided. A liability is recognized for the amount expected to be paid if the Company has a present legal or constructive obligation to pay this amount as a result of past service provided by the employee and the obligation can be estimated reliably.

(i) Provisions (other than for employee benefits) and contingent liabilities

A provision is recognized if, as a result of a past event, the Company has a present legal or constructive obligation that can be estimated reliably, and it is probable that an outflow of economic benefits will be required to settle the obligation. Provisions are determined by discounting the expected future cash flows (representing the best estimate of the expenditure required to settle the present obligation at the balance sheet date) at a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the liability. The unwinding of the discount is recognized as finance cost.

Contingent liabilities

Contingent liabilities are recognized only when there is a possible obligation arising from past events, due to occurrence or non-occurrence of one or more uncertain future events, not wholly within the control of the Company, or where any present obligation cannot be measured in terms of future outflow of resources, or where a reliable estimate of the obligation cannot be made. Obligations are assessed on an ongoing basis and only those having a largely probable outflow of resources are provided for.

(j) Revenue recognition

Revenue is recognized to the extent that it is probable that the economic benefits will flow to the Company and the revenue can be reliably measured, regardless of when the payment is being made. Revenue is measured at the fair value of the consideration received or receivable, taking into account contractually defined terms of payment and excluding taxes or duties collected on behalf of the government. The Company has concluded that is the principal in all of its revenue arrangements.

The specific recognition criteria described below must also be met before revenue is recognized

Maintenance service income

The Company recognizes maintenance service income over time, using input method to measure progress towards complete satisfaction of the service, as the customer simultaneously receives and consumes the benefits provided by the Company. Revenue pertaining to service income towards parking services is recognized as and when the services are rendered. The Company collects taxes on behalf of the government on the above activities and, therefore these are not economic benefits flowing to the Company. Hence, they are excluded from revenue. Accrued maintenance service income as at the period end is included in unbilled revenue.

Variable consideration

If the consideration in a contract includes a variable amount (like volume rebates/incentives, cash discounts etc.), the Company estimates the amount of consideration to which it will be entitled in exchange for rendering the services to the customer. The variable consideration is estimated at contract inception and constrained and it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognized will not occur when the associated uncertainty with the variable consideration is subsequently resolved. The estimate of variable consideration for expected future volume rebates/ incentives, cash discounts etc., are made on the most likely amount method. Revenue is disclosed net of such amounts.

Other income

(i) Interest income or expense is recognized using the effective interest method.

The 'effective interest rate' is the rate that exactly discounts estimated future cash payments or receipts through the expected life of the financial instrument to:

- the gross carrying amount of the financial asset; or
- the amortized cost of the financial liability.

In calculating interest income and expense, the effective interest rate is applied to the gross carrying amount of the asset or to the amortized cost of the liability.

(ii) Other items of income are accounted as and when the right to received basis

(k) Leases

The Company has applied Ind AS 116 'Leases' (Ind AS 116) with a date of initial application of April 1, 2019 using modified retrospective approach, under which the cumulative effect of initial application is recognized as at April 1, 2019.

At inception of contract, the Company assesses whether the Contract is, or contains a lease. A contract is, or contains a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration. At inception or on reassessment of a contract that contains a lease component, the Company allocates consideration in the contract to each lease component on the basis of their standalone price.

Company as a Lessor

Leases in which the Company does not transfer substantially all the risks and rewards incidental to ownership of an asset are classified as operating leases. Rental income from investment property is recognized as part of revenue from operations in statement of profit and loss on a straight-line basis over the term of the lease except where the rentals are structured to increase in line with expected general inflation. Lease incentives granted are recognized as an integral part of the total rental income, over the term of the lease. Accrued lease rental assets are included as part of unbilled revenue.

(l) Income tax

Income tax comprises current and deferred tax. It is recognized in statement of profit and loss except to the extent that it relates to an item recognized directly in equity or in other comprehensive income.

Current tax

Current tax comprises the expected tax payable or receivable on the taxable income or loss for the year and any adjustment to the tax payable or receivable in respect of previous years. The amount of current tax payable or receivable is the best estimate of the tax amount expected to be paid or received that reflects uncertainty related to income taxes, if any. It is measured using tax rates enacted or substantively enacted at the reporting date.

Current tax assets and current tax liabilities are offset only if there is a legally enforceable right to set off the recognized amounts, and is intended to realise the asset and settle the liability on a net basis simultaneously.

Deferred tax

Deferred tax is recognized in respect of temporary differences between the carrying amounts of assets and liabilities for financial reporting purposes and the corresponding amounts used for taxation purposes. Deferred tax is also recognized in respect of carried forward tax losses and tax credits. Deferred tax is not recognized for temporary differences arising on the initial recognition of assets or liabilities in a transaction that is not a business combination and that affects neither accounting nor taxable profit or loss at the time of the transaction.

Deferred tax assets are recognized for unused tax losses, unused tax credits and deductible temporary differences to the extent that it is probable that future taxable profits will be available against which they can be used. Future taxable profits are determined based on business plans of the Company. Deferred tax assets – unrecognized or recognized, are reviewed at each reporting date and are recognized/ reduced to the extent that it is probable/ no longer probable respectively that the related tax benefit will be realised.

Unrecognized deferred tax assets are reassessed at each reporting date and recognized to the extent that it has become probable that future taxable profits will be available against which they can be used.

Deferred tax is measured at the tax rates that are expected to apply to the period when the asset is realised or the liability is settled, based on the laws that have been enacted or substantively enacted by the reporting date. Deferred tax assets and liabilities are offset if there is a legally enforceable right to offset current tax liabilities and assets, and they relate to income taxes levied by the same tax authority on the same taxable entity, or on different tax entities, but they intend to settle current tax liabilities and assets on a net basis or their tax assets and liabilities will be realised simultaneously.

(m) Borrowing costs

Borrowing costs are interest incurred in connection with the borrowing of funds. Borrowing costs directly attributable to acquisition or construction of an asset which necessarily take a substantial period of time to get ready for their intended use are capitalized as part of the cost of that asset. Other borrowing costs are recognized as an expense in the period in which they are incurred.

(n) Cash and cash equivalents

Cash and cash equivalent comprise of cash on hand and at banks including short-term deposits with an original maturity of three months or less, which are subject to an insignificant risk of changes in value. Other bank deposits which are not in the nature of cash and cash equivalents with a maturity period of more than three months are classified as other bank balances.

(o) Statement of cash flow

Cash flows are reported using the indirect method, whereby profit / loss before tax is adjusted for the effects of transactions of a non cash nature and any deferrals or accruals of past or future cash receipts or payments. The cash flows from regular revenue generating, financing and investing activities of the Company are segregated.

(p) Errors and estimates

A change in an accounting estimate that results in changes in the carrying amounts of recognized assets or liabilities or to the profit or loss is applied prospectively in the periods of change.

Discovery of errors results in revision retrospectively by restating the comparative amounts of assets, liabilities and equity of the earliest prior period in which the error is discovered.

(q) Operating cycle

Based on the nature of activities of the Company and the normal time between acquisition of assets and their realisation in cash or cash equivalents, the Company has determined its operating cycle as 12 months for the purpose of classification of its assets and liabilities as current and non-current.

(r) Current versus non-current classification

The Company presents assets and liabilities in the balance sheet based on current/ non-current classification. An asset is treated as current when it is:

- Expected to be realised or intended to be sold or consumed in normal operating cycle
- Held primarily for the purpose of trading
- Expected to be realised within twelve months after the reporting period
- Cash or cash equivalents unless restricted from being exchanged or used to settle a liability for at least twelve months after the reporting period.

All other assets are classified as non-current.

A liability is treated current when it is:

- Expected to be settled in normal operating cycle
- Held primarily for the purpose of trading
- Due to be settled within twelve months after the reporting period, or
- There is no unconditional right to defer the settlement of the liability for at least twelve months after the reporting period

The Company classifies all other liabilities as non-current.

Considering the revenue generating potential of the existing built up area, the Company follows discounted cash flows technique and income capitalization approach. Discounted cash flow approach is based on the present value of the future receivable net income from the current operational leases/ revenues. These cashflows are then discounted at an appropriate discount rate linked with risk adjusted discounting factor to arrive at the sale value for the operational project components. Income capitalization approach envisages capitalizing the annual net rent receivable/ achievable from a property on market value basis using appropriate yield for a respective asset class. Since the approach envisages arriving at the capital value, the entire super built up area/ leasable area is considered for arriving at Market value along with associate revenue generating components. The fair value is the average of the fair values arrived under the discounted cash flow method and income capitalization approach.

36 (i) Withdrawal of audit reports on financial statements for the years ended March 31, 2018 and 2019

The statutory auditors of earlier years have notified vide letter dated December 17, 2020, that they withdraw their audit reports on the financial statements as of and for the financial years ended March 31, 2018 and 2019 as they do not continue to remain valid and informed the Company that auditor's report on the financial statements referred above must no longer be associated with the said financial statements. The Company, based on advice received from its external legal counsel, has replied that it rejects the above letter in its entirety and in accordance with the Companies Act, the financial statements for the years ended March 31, 2018 and 2019 remain audited, as the erstwhile auditors motion to withdraw the audit reports is not legally acceptable.

The Company has held the Annual General Meeting for adopting the audited financial statements for the year ended 31 March 2020 and 2021 dated January 27, 2022 and September 16, 2022. The Company has filed the annual return with Ministry of Corporate Affairs (MCA) and filed an application for compounding the delays in holding the Annual General Meeting for the years ended March 31, 2020 and 2021.

(ii) Overview and nature of certain financial irregularities

The Company had entered into a Development Management Agreement ("DMA") dated May 19, 2017 (including amendments thereto, if any) with Global Entropolis (Vizag) Private Limited ("GEVPL"/"DM") and Shriram Properties Limited (the parent of GEVPL as the confirming party to the agreement), towards the development of the identified phases of the project at Chennai, for a DM fees payable pursuant to the terms and conditions set forth in the DMA. During the year, based on certain irregularities observed during the course of reconciling balances with GEVPL, current board of directors at the behest of Shareholders of the Company initiated an independent investigation by external firms.

On the basis of inquiries, reconciliations, investigations, etc. carried out by board of directors at the behest of Shareholders of the Company through these external firms, payments aggregating to INR 14,087.65 lakhs were made by the Company were identified to be not covered under the DMA. The DM clarified to the Company that the parties to whom these payments were made by the Company were neither appointed nor approved by the DM. The payments were approved and/or directed by the erstwhile Director to various unapproved parties and were misrepresented to be payments made under the DMA, without the authorization of the Board of Directors. Such payments were identified through the investigation by external firms to be made to parties under two categories: (a) INR 10,283.53* lakhs to firms / entities owned by the erstwhile Director, his parents or relatives, and (b) INR 3,804.12* lakhs to other identified vendors upon instructions from the erstwhile director where investigation as to a link with the erstwhile director are underway by the police authorities. Such investigation also indicated that the erstwhile Director may have abused his fiduciary position by willfully destroying, falsifying and altering the records and by providing wrongful authorizations to payments. [*The actual payment made to the parties were net of tax]

The Company has filed a complaint with The Commissioner of Police, Chennai pursuant to which a First Information Report dated November 23, 2020 was filed against the erstwhile Director, his relatives and certain entities associated with him. Chargesheet is yet to be filed by the Police department. Therefore, no case is being heard at any court of law. On November 27, 2020, Income tax department also conducted search and seized the documents pertaining to the abovementioned transactions.

Based on the above and on the basis the information available/ascertained through the aforesaid investigation, inquiries and reconciliations, the adjustments aggregating to INR 14,087.65 lakhs arising from the financial irregularities, unsupported payments, errors etc. have been recorded and disclosed in the financial statements for the year ended March 31, 2020.

i) Contingent liability

Income tax matters - Search and seizure

On November 27, 2020, Income tax department conducted a search and seized the documents pertaining to the transactions mentioned in Note 36(ii). The Company had received notice under section 153C and under section 142(1) of the Income Tax Act ("Act") on December 11, 2021 and December 15, 2021 respectively requiring the Company to submit revised tax returns and to furnish details mentioned in the notice for the Assessment years starting from 2015-16 to 2020-21. The Company has duly filed revised tax returns for the above mentioned Assessment Years as per the requirements of the notice. The Income Tax Department had issued notice under section 143(2) in response to the revised returns filed by the Company.

Assessment for these years was completed vide order under section 143(3) r.w.s 153C of the Act dated March 31, 2023. As per the said order tax/ interest/ penalty demand of INR 22,738.32 lakhs was determined as payable by the Company for the Assessment years 2018-19, 2019-20 and 2020-21.

Appeals has been filed before the Commissioner of Income Tax (Appeals) in April, 2023 against all the adjustments made in the assessment order for assessment years 2018-19, 2019-20 and 2020-21. The Company is awaiting further communication from the CIT(A) in this regard.

Further rectification application dated April 24, 2023 has been filed before the JAO for rectifying the mistakes apparent from record under section 154, of the Act which is awaiting adjudication.

- (i) *As mentioned in Note 36(i), the statutory Auditors of earlier years have notified vide letter dated December 17, 2020, that they withdraw their audit reports on the financial statements as of and for the financial years ended March 31, 2018 and 2019 as they do not continue to remain valid and informed the Company that auditor's report on the financial statements referred above must no longer be associated with the said financial statements. The Company based on advice received from its external legal counsel, has replied that it rejects the above letter in its entirety. The Company believes that in accordance with the Companies Act, the financial statements for the years ended March 31, 2018 and 2019 remain audited and the erstwhile auditors motion to withdraw the audit reports is not legally acceptable.*

Given the dispute between the Company and the predecessor auditor with respect to the previously issued audit reports of the Company by the predecessor auditor, while we have audited adjustments made to the previously issued financial statements, we are unable to obtain sufficient appropriate audit evidence as to how this dispute would be finally concluded upon and therefore any impact on the previously audited financial statements of the Company for the year ended March 31, 2019 or prior periods is currently not determinable.

Board's Explanation/Comments:

The Company based on advice received from its external legal counsel, has replied to the erstwhile auditors that it rejects the position completely. The Company believes that in accordance with the Companies Act, the financial statements for the years ended March 31, 2018 and 2019 remain audited and the erstwhile auditors motion to withdraw the audit reports is not legally acceptable. Further the Company has not received any communication from any of the regulatory authorities on

(ii) Disclaimer of Opinion on the Internal Financial Controls:

The system of internal financial controls with reference to financial statements of the Company at March 31, 2024 was not made available to us to enable us to determine if the Company has established adequate internal financial controls with reference to financial statements and whether such internal financial controls were operating effectively as at March 31, 2024.

Board's Explanation/Comments:

The Board takes cognizance of the significance of the system and control framework. The Board and the management of the company are striving continuously for ensuring the establishment of a stringent and effective internal financial control framework for effective controls for the company. The Risk and control authority matrix has been adopted and implemented for the significant class of transactions. The said framework will also ensure effective implementation of the financial controls commensurate with the size of the Company.

Companies (Auditor's Report) Order, 2020:

Further, the report on Companies (Auditor's Report) Order, 2020 has no adverse remarks except the observation with respect to maintenance of the books of account in electronic mode. The observation is summarized below:

- (iii) *In Our opinion, proper books of account as required by law have been kept by the Company so far as it appears from our examination of those books except that the back-up of the books of account and other relevant books and papers in electronic mode has not been kept on servers physically located in India on daily basis during 1 April 2023 till 7 August 2023.*
- (iv) *Based on our examination, which included test checks, Company has used an accounting software from third party service provider for maintaining its books of account. In the absence of reporting on compliance with the audit trail requirements in the independent auditor's report in relation to controls at service organisation for such accounting software, we are unable to comment whether audit trail feature of the said software was enabled and operated throughout the year for all relevant transactions recorded in the software or whether there were any instances of the audit trail feature being tampered with.*

Board's Explanation/Comments:

- (iii) *During the year under review, the Company has been maintaining its books of accounts in electronic mode through globally renowned accounting software namely Yardi. As a process, the backup of the data in Yardi is automatic and saved on the servers located outside India. At any given point of time, the backups for last fourteen days are available. Since, this amendment by MCA was given immediate effect (Aug'22), the Company was not able to comply with this provision of the Act immediately during the FY 24. However, to ensure compliance with these amended provisions, your Company has put in additional controls and started taking backups*

The IT team has been working with Yardi and the same has been enabled subsequently. Accordingly, the auditors will continue to report the factual position for the current year and the same will be updated in the auditor's report from next year onwards.

The Secretarial Auditor of the Company has not reported any qualification, reservation or adverse remark or disclaimer in their independent report for the financial year ended March 31, 2024.
